



## AC Milan Summer Training Camp 18th August – 22nd August 2014 in London!

We are proud to present the second AC Milan Junior Camp to be held in the UK, in Baldock (London), in collaboration with the football school of AC Milan. Europe's most successful football club is offering the chance to all football-mad boys and girls, aged 6 to 14, to learn the tricks and techniques of Italian champions. The participants will be divided into groups according to age and ability, to ensure a training program tailored to individual skills. In addition to twice daily training sessions there is a lunch provided along with a varied free time program. The training camp will take place on the artificial pitch at The Arena in Baldock, and includes the following:
